Ms. Markt stated that this would be like the 10-year grant that formed the Youth Community Coalition, but this will be establishing coalitions in 5 communities in Boone County. Ms. Markt stated that it would reach out to those communities and help them to identify what the needs of youth are in their community and build up collaborations around those needs.

Ms. Markt stated that this is funded by Substance Abuse and Mental Health Services Administration. Mr. Hutton asked if this was a state agency. Mr. Steinhaus stated that this is a federal agency. Ms. Markt stated that it would address the issues of alcohol, tobacco use and electronic cigarette use.

Mr. Hutton asked if there were any comments or questions. All board members approved of Resolution 109. Mr. Hutton called for a motion to approve Resolution 109 as presented. A motion was made by Mr. Lewis. Second made by Ms. Oliveri. Upon a roll call vote of the motion, the following vote was recorded:

Boone County Children's Services board to support evidence-based programs which promote healthy lifestyles among children and youth, strengthen families, and provide home-based and

community-based family intervention programs in Boone County

Background Information:

On November 6, 2012, the citizens of Boone County passed County of Boone Proposition 1, which created a Children's Services Fund for children and youth nineteen years of age or less in Boone County. The Boone County Children's Services Board (BCCSB) was appointed by the County Commission and entrusted to oversee this Fund.

The Board believes that it should invest in meaningful services to children, youth and families in a way that utilizes multiple effective strategies. The Board has released an RFP seeking applications for purchase of services programs. The funding cycle for this RFP is January 1, 2018 – December 31, 2018 with opportunity for two renewal cycles.

CHA Low-Income Services will submit a total of three applications to the BCCSB for funding in 2019. Proposed services and estimated budgets are below:

Resolution 110: Healthy Home Connections\$443,000 (1 year, Option to Renew)

The Healthy Home Connections (HHC) program will combine Federal, Local, and County funding sources to provide case management and service coordination for all families with children under the age of nineteen who receive housing assistance the Housing Authority of the City of Columbia. The proposal will apply the evidence-based HUD Resident Services Coordinator model to support families participating in the Housing Choice Voucher Program, Project Based Voucher Program, and Public Housing. HHC will employ four full-time case managers and one intake/assessment coordinator. The proposal asks BCCSB to fund four positions and to up to 12 monthly events designed to build social connections and improve family/child interaction. Case managers will work together to provide home visits, allocate incentives to encourage participation in needs assessments and training workshops, and provide on-going case management designed help families identify goals, make plans, and work together toward the success of each family member. The proposal includes \$167,655 Therapeutic Mentoring sub-contracted to Big Brothers/Big Sisters.

Resolution 111: Moving Ahead Afterschool and Summer ... \$336,000 (1 year, Option to Renew)

This proposal will support the Moving Ahead Afterschool and Summer Program. It expands on previously funded trauma-informed proposals to include additional funding for out-of-school activities and to introduce evidence-based social emotional learning activities utilizing trauma-informed practices. The proposal is intended to supplement other funding for standard out-of-school programming like homework assistance, academic enrichments, meals and active play. It will also seek funding for a SEL Coordinator, a licensed counselor, and a case manager to employ additional evidence-based practices to help staff, students and families identify goals, make plans, and work together toward the success of each student and their entire family.

Resolution 96: YC2 Communities that Care Program \$175,000 (1 year, Option to Renew 2X)

This proposal on behalf of the Youth Community Coalition continues work that was previously funded by the BCCSF in 2017. YC2 is creating a county wide positive youth development network by building the capacity of Boone County Communities to promote the positive social, emotional, and mental health development of children. YC2 is engaging county stakeholders from multiple sectors to foster collaboration around youth mental health and behavioral health outcomes. The goal of the network is to develop local community coalitions that support an environment promoting positive youth outcomes. Funding will support staff time, volunteer stipends, training, mileage, and supplies.

Staff Recommendation: Adopt Resolutions #110 - 112 authorizing the submission of grant applications to the Boone County Children's Services Board, and authorizing the execution of contract award agreements and the implementation of the programs as described in the funding applications.
